



Display Monitor Site Licences

During 1997, Meko introduced a new electronic version of Display Monitor to supplement the paper-only format. The move was made at the request of subscribers who wanted

- Faster delivery
- Easier circulation for multiple readers
- Back issues that could be indexed and searched

To meet this need, Meko now offers site licences for the publication. Each week, an electronic version of the newsletter is prepared in Adobe Acrobat format (for A4 or letter paper) and is mailed to a nominated e-mail account at the site (although this is likely to change to a password protected web download in the future). A sample of the newsletter can be downloaded from our web site and a free Acrobat reader can be obtained from <http://www.adobe.com>.

Recipients can print copies of the newsletter or circulate them, within the scope of the site licence, using e-mail or internal databases. The Acrobat format preserves formatting and graphics within the document.

Large companies can gain a much greater benefit from this facility and so we charge a site licence according to the size of the company. As a shorthand for the size of the company, we use the number of employees (not the number of readers!).

If you have individual requirements that don't fit this scheme, please contact us so that we can establish what scope of licence would be appropriate. Subscribers who have a site licence can purchase additional paper copies for use and delivery at the site at a cost that reflects the postage and printing costs of the additional copies. Please contact us if you have requirements for additional copies so that we can establish the cost.
